

## Defining Terms

### NOFO/NOFA

The Notice of Funding Opportunity and the Notice of Funding Availability, better known as NOFO and NOFA, are the means by which the federal government announces grant opportunities. This is also the notice that Serve Washington applies to, as the prime grantee, on behalf of AmeriCorps State programs in Washington.

### RFGA

The Request for Grant Applications, better known as RFGA, is the means by which Serve Washington announces grant opportunities for subgrantees. Applicants applying to Serve Washington must follow the RFGA for all AmeriCorps State grant opportunities. The RFGA may reference the federal NOFO/NOFA, but applicants should carefully review the RFGA as the primary means in which to apply for an AmeriCorps State program in Washington.

### Competitive Funds

Competitive grants are AmeriCorps program proposals that are put into a pool of applicants from across the country for a national grant review process. Good for evidenced-based, well-established program models and organizations familiar with federal grants management. Usually 20-50 MSY. Much larger pool of funds to award from.

### Formula Funds

Formula grants are AmeriCorps program proposals that are put into a pool of applicants at the state commission level for a decision on funding made by the state's Commissioners. Good for evidenced-informed, newer program models and organizations just learning federal grants management. Usually 10-30 MSY. Much smaller pool of funds to award from.

## Grant Opportunities

Grant opportunities for AmeriCorps State programs primarily occur spring and fall. There may be rare occasions in which Serve Washington releases a targeted RFGA for specialized programming. Upcoming opportunities include:

- **Fall 2022** – Competitive Competition – **Program Year 23-24** (apply during planning grant year; consecutive and sequential award from planning grant directly to operation grant)
- **Spring 2023** – Formula Competition – **Program Year 23-24** (apply during planning grant year; consecutive and sequential award from planning grant directly to operation grant)
- **Fall 2023** – Competitive Competition – **Program Year 24-25** (apply after planning grant year; gap year between planning grant and operation grant)
- **Spring 2024** – Formula Competition – **Program Year 24-25** (apply after planning grant year; gap year between planning grant and operation grant)

## Member Positions vs MSY vs Slot Types

Member positions vary based on program design. Member positions are often referred to in terms such as a Member Service Year, or MSY, and/or as a slot type. An MSY is similar to an FTE in the employment world, it is simply a reflection of the unit of time. Similarly, a slot type, is also a reflection of the type of member position and MSY. MSYs and slot types also govern two important details; the maximum cost per MSY and member benefits. The maximum cost per MSY is the associated dollar amount applicants can request for federal funding. Member benefits, such as, living allowance and education awards, are determined by slot type. The maximum cost per MSY and member benefits vary year to year and are defined in the NOFO/NOFA/RFGA.
